G Wood Son & Co. was formed in 1876 through a partnership of Gilbert Wood, 1828-1886, his son Peter Wood, 1855-1921, and James Gartrell, 1847-1925. 1/ Branches were also established in Broken Hill and in Western Australia. G Wood Son & Co trading as Anchor Foods, continued in business and was acquired by Bennett & Fisher Limited in 1978. 2/ Then on sold to CSR Limited in 1987. 3/ Anchor Foods were subsequently acquired by Uncle Tobys Company Limited c.1991.
