- Box 39 Realia (mostly militaria)
1. World War I memorial plaque (medallion) in wrap and envelope, sent to Mr J. McGuire, Jetty Road, Largs Bay, recognizing the death of his son, Private Julian Edmond McGuire. McGuire enlisted in 1915, and served in the 4th Field Ambulance. He died in France in August 1918. Julian was an older brother to Paul McGuire.
 2. Insignia from Paul McGuire's naval uniform comprising: commanders' hat badge, and two special Naval Reserve commander insignia.
 3. World War II service medals awarded to Paul McGuire. They include the Australia Service medal 1939-1945 and the war medal 1939-1945; both of these are on a bar with a coronation medal 1953.
 4. A small dress set with all three medals together with the CBE awarded to Paul McGuire in 1951.
 5. Bar to the medals.
 6. Shoulder badge for a 'war correspondent' pinned to a dark green cloth patch.
 7. Miscellaneous items comprising a strip of ribbon, cuff link and small bar.
 8. Small 'Naval jack of Australia' (flag), 19.6 x 32.2 cm (irreg.)
 9. CBE awarded to Paul McGuire on 1 January 1951.
