At a meeting held in Adelaide on 15 August 1905 a motion was passed that a Clerks' Association be formed in South Australia. A national body was registered in 1911 and a delegate elected from South Australia; however it appears that the state body was not registered in South Australia until 1919. In the late 1920s the national body became known as the Federated Clerks' Union (FCU).

Records of the South Australian Branch were handed over to the Mortlock Library in 1992.
