- Utilisation of Board funds for the development of a First Nations Strategy
 Resolution: Megan Berghuis recommends that the \$97k is utilised to develop a new
 strategy to strengthen the State Library's commitments to First Nations people.
- Board invitation to ARG Chair
 Resolution: Megan Berghuis recommends that an invitation be extended to ARG chair
 twice per year to report on activities of the Aboriginal Reference Group.
- Board Member Kedeisha Kartinyeri role as a First Nations representative to guide Board decision making Resolution: Megan Berghuis recommends that Kedeisha Kartinyeri's role as a First Nations representative on the Board be recognised, strengthening link between ARG
